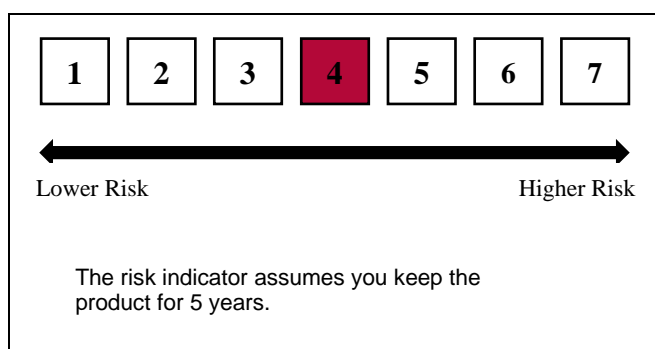
**What is the product?**

<b>Type</b>	This product is qualified as a Packaged Retail Investors and Insurance Product ("PRIIP") and is a class of shares of the sub-fund Chindia Equity Fund (the "Sub-Fund") in the fund Ashburton Emerging Markets Funds (the "Fund").
<b>Objectives</b>	<p>The Fund is a non-UCITS fund and is an open-ended investment company based in Jersey.</p> <p>The objective of the Sub-Fund is to achieve long-term capital growth through equity or equity related investments predominantly in the stock-markets of China and India.</p> <p>The Sub-Fund will focus on the quality and attractiveness of individual companies rather than the outlook for particular markets. The Sub-Fund will also invest in companies traded in other markets where a significant proportion of growth in their underlying business is set to derive from China or India.</p> <p>The Sub-Fund should be viewed as a medium to long-term investment (Recommended Holding Period of at least 5 years). You can, however, withdraw your investment at any time.</p>
<b>Intended retail investor</b>	The product is suitable for medium to long term investment and for investors wanting to gain exposure to the equity markets of China and India.
<b>Maturity date</b>	This product has no maturity date.

**What are the risks and what could I get in return?**

**Risk indicator**



This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

### **What are the costs?**

**Presentation of costs**  
The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest USD 10 000. The figures are estimates and may change in the future. The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor.

## How long should I hold it and can I take my money out early? Recommended Holding Period: 5 years

The fund should be viewed as a medium to long-term investment (at least 5 years). You can, however, redeem your investment at any time by sending a redemption request to Ashburton (Jersey) Limited before 10 a.m., on any business day in Jersey, to be dealt on that dealing day.

It is, however, difficult to estimate how much you would get back if you cash in your investment before the end of the recommended holding period (at least 5 years).
