You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is qualified as a Packaged Retail Investors and Insurance Product ("PRIIP") and is a class of shares of the sub-fund Global Growth Dollar Feeder Fund (the "Sub-Fund") in the fund Ashburton Global Investment Funds Limited (the "Fund").

The Fund is a non-UCITS fund and is an open-ended investment company based in Jersey. The Fund is a company which is registered with limited liability in Jersey in accordance with the provisions of the Companies (Jersey) Law of 1991.

Objectives The investment objective of the Global Growth Dollar Feeder Fund is to invest in the Dollar share class of the Ashburton Investments SICAV - Global Growth Fund ("Global Growth Fund"). The objective of the Global Growth Fund is to maximise growth over the long term, without exceeding a maximum equity exposure of 75%.

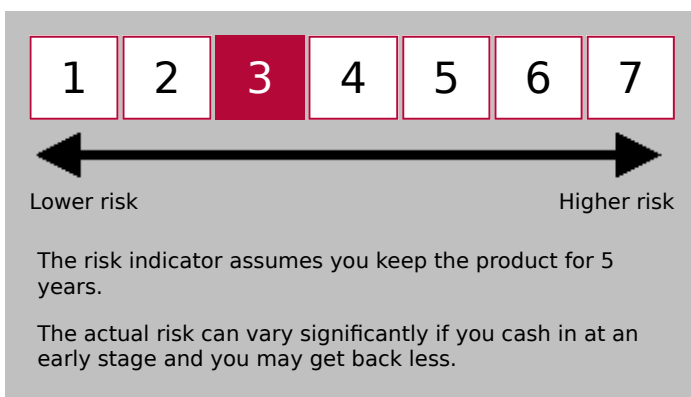
The Sub-Fund should be viewed as a medium to long-term investment (Recommended Holding Period of at least 5 years). You can, however, withdraw your investment at any time.

Intended retail investor The product is suitable for medium to long term investment and for investor wanting to gain exposure to international equities, bonds, cash, money markets and some indirect exposure to non-traditional asset classes such as real estate, commodities, hedge funds or private equity.

Maturity date This product has no maturity date.

What are the risks and what could I get in return?



Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest USD 10 000. The figures are estimates and may change in the future.

How long should I hold it and can I take my money out early?**Recommending Holding Period: 5 years**

The Fund should be viewed as a medium to long-term investment (at least 5 years). You can, however, redeem your investment at any time by sending a redemption request to Ashburton (Jersey) Limited before 12 p.m. on any business day in Jersey to be dealt on the next dealing day. It is, however, difficult to estimate how much you would get back if you cash in your investment before the end of the recommended holding period (at least 5 years).
