

AFRICA EQUITY OPPORTUNITIES FUND

Investment objectives & strategy

The investment objective of the Sub-Fund is to maximise risk-adjusted returns over the long run while preserving capital, regardless of market conditions, by investing in companies whose primary source of income is from, or whose major assets are based on, the African continent. It is anticipated that at least 80% of the Fund will be invested in companies listed on African stock exchanges and the balance on stock exchanges outside Africa. The Fund can also invest up to 10% in selected investment opportunities, such as pre-IPO opportunities or unlisted investments.

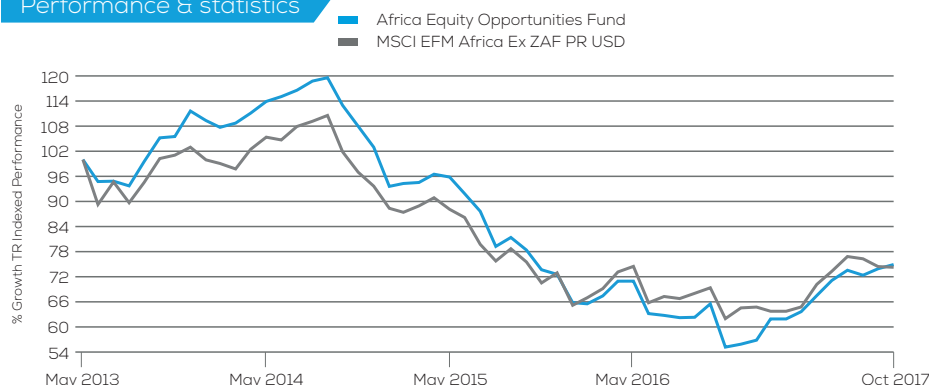
Investor profile

This Fund is designed for investors wishing to participate in capital markets and may be most appropriate for investors with a medium to long term investment horizon, as losses may occur due to high market fluctuations.

Fund activity

- Gains in Nigeria (2.2%) and Morocco (0.5%) largely offset weakness in Mauritius (-3.8%), Egypt (-1.4%) and Kenya (-1.0%). Mauritius' long rally ended and Egypt's weakness was from Commercial International Bank (-3.4%) that was also the largest negative contributor in the index. A strong US dollar had a negative effect, especially in currency areas with a Euro association (Morocco, Mauritius and francophone West Africa).
- The Fund outperformed strongly in Egypt and Mauritius. The Fund's consumer shares in Egypt were the biggest contributor to the gains, notably MM Group (22.2%) and Eastern Company (7.0%). Nigerian banking shares (6.4%) also contributed strongly. Seplat Petroleum's 5.5% decline was the largest negative contributor, due to it being the largest position in the portfolio. The Brent oil price rallied 7.8% in the month and this should have a positive effect on Nigeria and the Fund's oil and gas exposure.

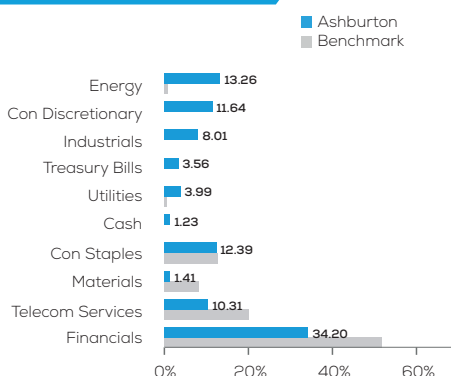

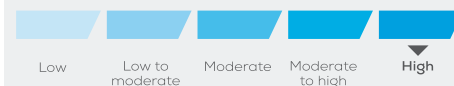

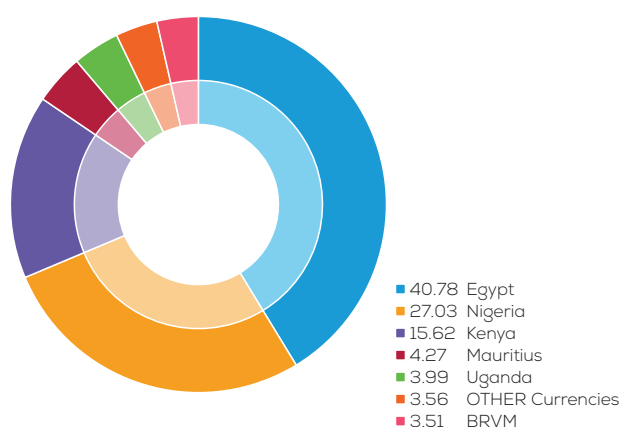

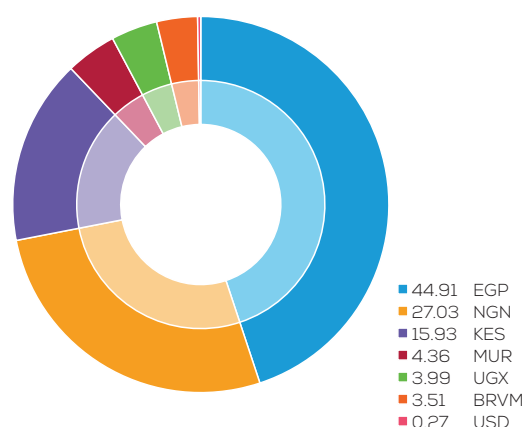
