## Introduction

The Ashburton Collective Investment Scheme in Securities Exchange Traded Funds ("the Scheme") is appointing a new management company FNB CIS Manco (RF) (Proprietary) Limited. The Scheme currently has five portfolios under management, namely:

## How will this impact your investments?

The impact of the new appointment will result in the changing of the name of the Scheme to the FNB Funds Collective Investment Scheme in Securities Exchange Traded Funds and its underlying portfolios. The portfolio names will be changed to:

- 1. FNB Government Inflation Linked Bond Exchange Traded Fund (FNB Inflation ETF)
- FNB Top40 Exchange Traded Fund (FNB Top40 ETF)
- FNB MidCap Exchange Traded Fund (FNB MidCap ETF) 3.
- FNB Global 1200 Equity Fund of Funds Exchange Traded Fund (FNB Global 1200 Equity FoFs ETF) 4.
- FNB World Government Bond Exchange Traded Fund (FNB World Government Bond ETF)
