## What is this product?

### Type

This is an investment fund established as a Company With Variable Capital (SICAV).

### Objectives

**Investment objective** The Sub-Fund aims to provide investors with growth in total return (capital plus income) over the medium to long term, without exceeding a maximum equity exposure of 60%.

**Investment policies** The Sub-Fund will allocate assets across a diversified range of asset classes, regions and currencies. The Sub-Fund may have up to 60%, and must have at least 20%, in equities. It must invest a minimum of 30% and may invest a maximum of 80% of its assets in a combination of fixed income, money market instruments and cash. The Sub-Fund may invest directly in securities as well as indirectly via collective investment schemes. It may also obtain indirect exposure to non-traditional asset classes, such as property, hedge funds and commodities by using these methods.

It may also invest its assets in derivatives, either to generate returns or to help manage the portfolio efficiently.

The Sub-Fund will have a minimum exposure to its base currency of 50% and may have a maximum exposure to currencies other than USD, EUR and GBP of 40% in aggregate.

The Sub-Fund may use derivatives to achieve aggregate exposure in excess of 100% of net asset value; but not greater than 350% under normal market conditions.

**Benchmark** The Sub-Fund is not a tracker fund. The Sub-Fund is actively managed. The Sub-Fund is managed in reference to a benchmark and its performance is measured against the composite benchmark of 50% FTSE WorldBIG Hedged to base currency + 50% FTSE All World Hedged to base currency.

**Redemption and Dealing** You can buy and sell shares in the Sub-Fund on any business day, as described in the prospectus. The price you

pay or receive will be based on Net Asset Value per share on the day the shares are bought or sold.

**Distribution Policy** The Share Class of the Sub-Fund does not pay out income or capital gains on the Fund's investments. Instead, these are reinvested.

**Launch date** The Sub-Fund was launched on 01/10/2014. The share class was launched on 20/10/2014.

**Currency** The base currency of the Sub-Fund is GBP.

**Switching** You may exchange shares free of charge to the same or another share class of another sub-fund as the Manager may permit. Please refer to the prospectus for further details.

### Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium-low level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

### Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the Board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The manufacturer, Ashburton (Jersey) Limited, is not entitled to terminate the product unilaterally.

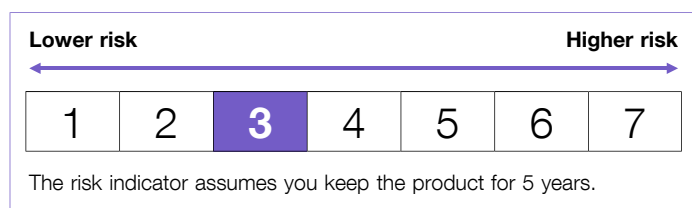

## What are the risks and what could I get in return?

### Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the Sub-Fund to pay you.

### Performance scenarios

### What happens if the Sub-Fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depository. Should we default, the depository would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

### What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- 10,000 GBP is invested.

### Recommended holding period: 5 years

The price you pay or receive will be based on Net Asset Value per share on the day the shares are bought or sold.
