What is this product?

Type

This is an investment fund established as a Company With Variable Capital (SICAV).

Objectives

Investment objective The Sub-Fund aims to maximise total return by investing in a global portfolio of equities issued by companies operating in both developed and emerging markets. The Sub-Fund will always have at least 80% of its assets invested in equity securities and may also invest in collective investment schemes.

Investment policies At least 80% of the Sub-Fund's total assets will be invested in Transferable Securities issued by companies, in different sectors and industries, operating in both developed and emerging markets, including Russia. The Sub-Fund will invest in equity, such as common stocks, preferred stocks, and other securities with equity characteristics, comprising warrants and units of eligible closed-ended Real Estate Investment Trusts (REITs), either directly or indirectly through financial derivative instruments. The Sub-Fund shall not invest more than 10% of its net assets in special purpose acquisition companies (SPACs).

The Sub-Fund may also invest up to 20% of its total assets in fixed income securities, such as corporate and government bonds. The Sub-Fund may invest in contingent convertible bonds and convertible bonds which will not exceed 20% of its total assets.

The Sub-Fund shall not invest more than 10% of its net assets in units of other Sub-Funds, UCITS and/or other UCIs, including eligible exchange traded funds.

Currency forwards may be used for Efficient Portfolio Management to reduce long equity backed exposure and hedge the Sub-Fund back to its reference currency of USD.

The Sub-Fund will also be able to invest in derivatives such as options, forwards, swaps, and futures the aggregate exposure of which will not exceed 20% of its net assets.

The Sub-Fund will be diversified by country while not being subject to any geographic restrictions.

The Sub-fund may hold ancillary liquid assets (i.e., bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes.

The Sub-Fund may, in order to achieve its investment goals, hold up to 50% of its net assets in cash equivalent.

The CISCA restrictions detailed on page 23 of the prospectus apply to this Sub-Fund since receipt of approval by the Financial Sector Conduct Authority of South Africa.

Benchmark The Sub-Fund is not a tracker fund and is actively managed. The Sub-Fund is not managed in reference to a benchmark.

Redemption and Dealing You can buy and sell shares in the Sub-Fund on any business day, as described in the prospectus. The price you pay or receive will be based on Net Asset Value per share on the day the shares are bought or sold.

Distribution Policy The Share Class of the Sub-Fund does not pay out income or capital gains on the Fund's investments. Instead, these are reinvested.

Launch date The Sub-Fund was launched on 01/12/2022. The share class was launched on 01/12/2022.

Currency The base currency of the Sub-Fund is USD.

Switching You may exchange shares free of charge to the same or another share class of another sub-fund as the Manager may permit. Please refer to the prospectus for further details.

Asset segregation The Sub-Fund is a sub-fund of Ashburton Investments SICAV, which comprises other sub-funds. The assets and liabilities of each sub-fund are segregated from other sub-funds of Ashburton Investments SICAV.

Intended retail investor

This product is intended for investors who plan to stay invested for at least 5 years and are prepared to take on a medium level of risk of loss to their original capital in order to get a higher potential return. It is designed to form part of a portfolio of investments.

Term

The Fund is open-ended and has no maturity date. Subject to the liquidation, dissolution and termination rights of the Board of the Fund as set forth in the Fund prospectus, the Fund cannot be automatically terminated. The PRIIP manufacturer, Waystone Management Company (Lux) S.A., is not entitled to terminate the product unilaterally.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Sub-Fund to pay you.

Performance scenarios

What happens if Waystone Management Company (Lux) S.A. is unable to pay out?

The Management Company has no obligation to pay out since the Fund design does not contemplate any such payment being made. You are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should the Fund default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

■ In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

■ 10,000 USD is invested.
