You are about to purchase a product that is not simple and may be difficult to understand.

### What is this product?

Type This product is qualified as a Packaged Retail Investors and Insurance Product ("PRIIP") and is a class of shares of the sub-fund Dollar Asset Management Fund (the "Sub-Fund") in the fund Ashburton Replica Portfolio Limited (the "Fund").

The Fund is a non-UCITS fund and is an open-ended investment company based in lersey.

The Fund is a company which is registered with limited liability in accordance with the provisions of the Companies (Jersey) Law 1991.

**Objectives** The objective of the Sub-Fund is to achieve an increase in the value of the Sub-Fund, whilst aiming to suppress volatility and risk, through a conservative allocation of assets between, primarily, international equities, fixed interest securities, cash or money market instruments and other investments.


> The Sub-Fund should be viewed as a medium to long-term investment (Recommended Holding Period of at least 5 years). You can, however, withdraw your investment at any time.

**Intended retail** The product is suitable for medium to long term investment and for investors wanting to gain exposure to **investor** international equities, bonds, cash and money markets.

# What are the risks and what could I get in return?



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to pay you.

# What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest USD 10 000. The figures are estimates and may change in the future.

## How long should I hold it and can I take my money out early?

#### **Recommending Holding Period: 5 years**

The Fund should be viewed as a medium to long-term investment (at least 5 years). You can, however, redeem your investment at any time by sending a redemption request to Ashburton (Jersey) Limited before 10 a.m., on any business day in Jersey, to be dealt on that dealing day.

It is, however, difficult to estimate how much you would get back if you cash in your investment before the end of the recommended holding period (at least 5 years).
