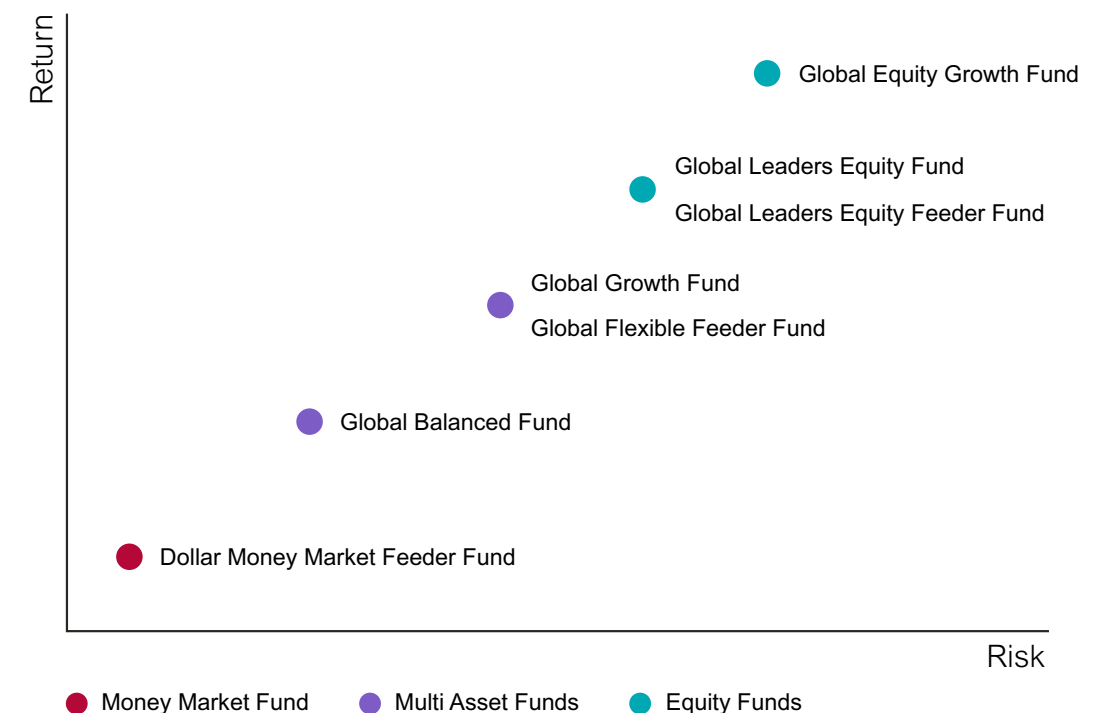
# Investing Offshore
