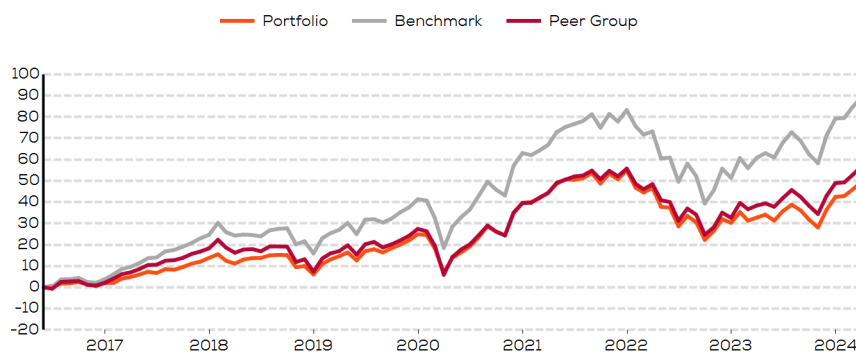
Investor profile

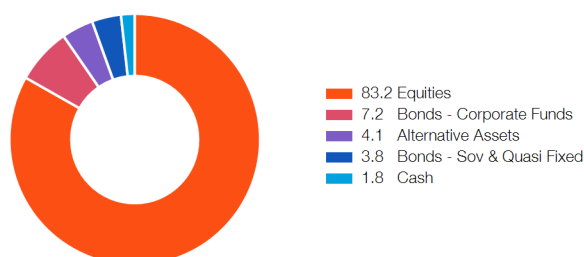

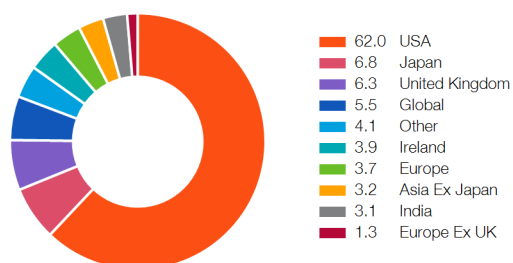

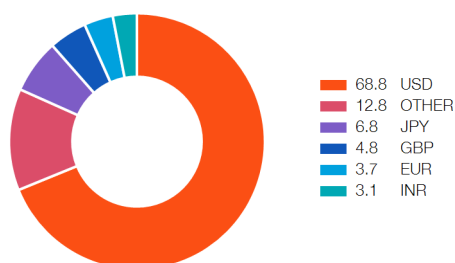
