
## Investor profile





## Definitions

| Total return:              | Total return accounts for two categories of return: income and capital appreciation. Income includes interest paid by fixed income investments, distributions or dividends. Capital appreciation represents the change in the market price of an asset.  |

| NAV (net asset value):     | This is the total value of assets in the portfolio less any liabilities, divided by the number of shares outstanding.  |
| TER (total expense ratio): | This is a measure of the total costs associated with managing and operating an investment fund.
