



Total return:	Total return accounts for two categories of return: income and capital appreciation. Income includes interest paid by fixed income investments, distributions or dividends. Capital appreciation represents the change in the market price of an asset.
NAV (not asset value):	This is the total value of essets in the partfelia less any liabilities, divided by the number of shares outstanding

NAV (net asset value)
