
Investor profile

Exposure to currencies, other than base currency, after hedging, will not exceed 50%.




Asset allocation %

Definitions

Total return:	Total return accounts for two categories of return: income and capital appreciation. Income includes interest paid by fixed income investments, distributions or
	dividends. Capital appreciation represents the change in the market price of an asset

This is a measure of the total costs associated with managing and operating an investment fund.
